



## For the Community:

The book sale raised \$78.90.

The Library will be celebrating veterans by serving them free coffee and muffins on Thursday November 9<sup>th</sup> from 9 am to 12 pm. I have created a flyer with a list of services that are available to local veterans. The Library is taking donations for our local senior shut- ins as part of our annual Christmas Baskets for Senior Citizens in cooperation with the Estancia Senior Center. Ms. Jones said that the budget is healthy, but she is concerned about the water enterprise revenue; it is not what it has been in the past. Hopefully, the installation of new meters will improve the accuracy of the meter account reading and improve revenue. She and her team will be watching this fund very closely to make sure that we do not exceed our budgeted expenditures and that we cut back expenditures in that fund if necessary. **NO ACTION, INFORMATION ONLY**

Mayor Dial informed all that there will be a Matanza on Saturday at the Legion and the cost will be \$10.00 a plate. Also there will be breakfast served at the school at 9:00am for Veterans Day. He told the Board that there is an issue with the distribution of our ESGRTs because of the EVSWA NMFA loan. Ms. Cabber from EVSWA is working on resolving this. Mayor Dial also talked about an incident that occurred at the Neil Mertz Judicial Complex. He said, in summary, that they are doing things in that building that hurt the community.
