Dear D'rese,

As you know, I am a big fan of Estancia. I am a native New Mexican and I have always appreciated the proximity Estancia has to I-40 and Albuquerque while providing a nice rural setting for its residents. I lived in Red River for 10 years and love small town living. I'm happy to hear you are doing a project that will be good for Estancia in many ways. Your RV park will be an attractive addition to town that will generate new revenue and fill a need for guests and workers in the area by providing a nice place for them to stay.

I have reviewed the zoning ordinance that was adopted in 2020 to confirm any issues I feel you may face in building this park. In my opinion, your park is a conforming use as well as a permissive use under the ordinance and is subject to the Special Use Zone requirements of section 14 which has provisions that squarely apply to your plans. Despite the fact your property is on both sides of a public road, you have one acre (minimum size for an RV park) which is "contiguous" property based on the definition of "contiguous" contained in section 4.B.5. The definitions in section 4 apply to the entire ordinance. There are no provisions in the Special Use Zoning section that contradicts the definition of contiguous property.

The ordinance is relatively short and concise and generally provides for objective application. There are some provisions that could be construed on a subjective basis if someone objected to your project. However, as long as the Town Board is reasonable about applying the ordinance to your project in an objective manner, they should have no problem approving your project.

As you know, the Ordinance requires you make proper application and pay the fee they have established, and the Town Board has to review your plan for compliance with the Ordinance. The town zoning officer can accept your application and information, but really can't give you approval since your use falls under the Special Use provisions of the Ordinance. Based on what you have done so far, I think you have met your obligations in presenting your plan. At this point, I would expect the Town Board to review your plan and be satisfied that your project is allowed under the terms of the Ordinance and that in addition to the benefit the town will enjoy, there won't be any harm done as articulated in the Ordinance. I would be quite surprised if your project is not approved without delay.

Again, I think you have an excellent and exciting project that should be a significant benefit to Estancia. As you know, I have had many years of experience with planning and zoning matters and I'll be more than happy to provide any further advice you may need if the Town Board has any concerns. But, I am confident you will be treated fairly and your plan should be well received.
