10.0 Mayor/Council Updates:

Trustee Hall- Trustee Hall had questions for Trustee Sanchez on the new Phone Line (internet) and Trustee Sanchez confirmed that it is in the works and it's going from Moriarty NM to Mountainair NM and it will be Fiber Optic

Trustee May- Gave an update on House Bill 10 Passing, House Bill 11 did not pass, Momma and the girls want a letter that says they are using town water. Also brought concerns on Walker Street and a huge pot hole.

Trustee Sanchez- Discussed about implementing a Youth Program since the pool is closed having movies in the park and advertising on social media, volunteering at the Police Department and Fire Department, pool, ballpark and possibly at Town Hall.

Trustee Lovato- Currently they have 60 Registrations for Little League with 40 pending in the cart. Working with Edwin to get the bleachers at Pumpkin Chunkin, Mayor Dial said that the contractor is going to pay for it since they were the last ones to touch it, and it was still under contract. Trustee Lovato will get with the Clerk to see about purchasing a Riding Lawnmower. Requirements for a name to be placed at the ballpark are Service to the town, Resident for 10 years or more, and they must be deceased. We need to put the Eagle at the Ballfield. Also wants to look into hiring a Ballfield Manager or a Parks and Rec that handles the park, ballfield and pool. Fire Chief Chris Wolonsky said he will get with PHI to see if they will deliver the Game Ball. The Grand Opening will be April 19th and 1st Game will start at 3pm

Mayor Dial- 3/20/2025 at 9am Solid Waste Meeting Chief Carter and Clerk Bernadette will be there to discuss purchasing the CYFD building at the Cost that they Owe (Government to Government purchase) Chief Carter said he spoke to the own behind the building and he said he would agree to an agreement for parking on a portion of his land. Don Chavez Agreed on the Monitor Well on his property (airport is land locked by him)
