8.0 Mayor/Council Updates:

Trustee Hall- Apologized for not being at the last meeting, one of his medications was making him sick. He also wanted to know about the current water situation. Mayor Dial told him samples were submitted to put well #4 online, and that they should have labs back in the next ten days and hopefully the state will approve it. Well #3 is pumping about 30 gallons a minute and is being run 24 hours a day. Well #9 is staying about 25 gallons a minute. Well #8 is doing 120 gallons a minute. We are sustaining.

Trustee May- Wanted to congratulate Patrick and thanked him for putting banners up, it was nice seeing them coming into town. She also said that the graduation was nice this year.

Trustee Sanchez- Baseball is a hit, he was at a car show this weekend and people were talking about it. People are wondering why construction has not started at the pool yet. He said that Edgewood was looking for a place because they want to build a pool, and they would be our competitor. He said that we needed to get the pool up and running. He thinks if Edgewood takes it, we will lose completely. Thanked the guys for handling the water situation.

Trustee Lovato- The baseball program is probably one of the most shocking turn of events that we have had lately in this town. They are generating at least one hundred to two hundred people a day when they have games there. He also thanked Chief Carter for being there and having his officers there. This baseball field has been one of the best investments for the community, it has brought everyone together. Trustee Lovato also mentioned that they now have to take care of the field. He also advocated that we hire someone to take care of the pool because it needs to be taken care of, so it won't deteriorate, and maybe someone to watch over the pool and baseball field. He thinks if someone had oversight of the pool we wouldn't be in this position, they would let us know what was going on. He knows Laura can't be looking over everything because she has a full-time job and I think she would love to have someone checking on that and letting her know what is needed. We need to take care of the baseball field and the pool. He also said he would like to get signs for the baseball field.

Mayor Dial- Chief Carter and Dannette from EVSWA are going to be on a zoom to approve the purchase of the building on main street. Robert's flooring is also coming to put new carpet in the boardroom so they could start having meetings there again. Only the board room is getting new carpet not the bathrooms or the hall way. Michelle Jones' first official day is next Tuesday.
