Mayor Dial explained that we have until July 31st to get in to compliance with the Water Trust Board and the Office of the State Engineer to be eligible to a loan to dig a new well. The Well 4 tests have been good. Work on Well 9 is being done. We are fortunate that the school is closed for the summer. We are waiting on a permit to drill deeper in Well 9.

**Trustee May** told her fellow trustees that she has signed up for the NMML Policy Committee and will be attending the meeting soon. She also recently attended the MRCOG meeting. She reminded all of the upcoming National Night Out that will be held on August 1st at the Fair Grounds. Lastly, she will be attending a Torrance County Special Meeting where they will discuss enacting Special Improvement Districts.

**Trustee Sanchez** said that the names added to the wall at the Estancia Legacy Baseball Field are a big hit. More names will be nominated and added every season.

**Trustee Lovato** said that the Estancia Little League season has come to an end and it was great!! The turnout was amazing. Tryouts for the Estancia USSSA Bean Valley Bombers are currently being held. The American Legion will host a Mush Ball tournament on the 4th of July; all ages are welcome and the tournament will begin at 10:00am.

Mayor Dial had no update for this meeting.
