PARTICIPATION IN LOCAL GOVERNMENT ROAD FUND PROGRAM ADMINISTERED &
TIME EXTENSION REQUEST

BY NEW MEXICO DEPARTMENT OF TRANSPORTATION

WHEREAS, the **Town of Estancia** and the New Mexico Department of Transportation enter into a
Cooperative Agreement.

WHEREAS, the total cost of the project will be **\$151,655** to be funded in proportional share by the
parties hereto as follows:

New Mexico Department of Transportation's share shall be 75% or **\$113,741.00**
and

Town of Estancia proportional matching share shall be 25% or **\$37,914.00**

TOTAL PROJECT COST IS **\$151,655.00**

Town of Estancia shall pay all costs, which exceed the total amount of **\$151,655.00**.

Now therefore, be it resolved in official session that **Town of Estancia** determines, resolves, and orders as
follows:

That the project for this Municipal Arterial Program Cooperative agreement is adopted and has a priority
standing.

The agreement terminates on **June 30, 2025** and the **Town of Estancia** is requesting an extension to **June 30, 2026**. The Town further incorporates all the agreements, covenants, and understandings between the parties hereto concerning the subject matter hereof, and all such covenants, agreements and understandings have been merged into the written agreement.

NOW therefore, be it resolved by the **Town of Estancia** to enter into Cooperative Agreement Control Number **HW2L500558** with the New Mexico Department of Transportation for LGRF Project for fiscal year **2024** for the **Planning, Design, Construction, Reconstruction, Pavement Rehabilitation, Construction Management, Drainage and Misc. Improvements of Highland Avenue from Scott Lane to the Senior Center, Berkshire Road from NMSR 41 to 4th Street, 4th Street from Highland Avenue to Berkshire Road** in the control of the **Town of Estancia** in **Torrance County**, New Mexico.
